Any local government that has not yet submitted an AFH that has been accepted by HUD must instead conduct an analysis of impediments (AI), which was required prior to 2015.

smoke Free Housing

The Housing Authority of Owensboro's Smoke Free policy went into effect on July 1, 2017. We developed partnerships with the American Lung Association and the Green River District Health Department to promote smoke free housing.

The American Lung Association received grant dollars from the Anthem Foundation and the money is to be used strictly for Smoking Cessation in Public Housing across the state of Kentucky. Grant funds provided the following:

- -Printed educational materials
- -Participates workbooks
- -CO monitor to test participates breathalyzer
- -Incentives for participates
- -Equipment and materials to host smoking cessation classes
- -Smoke Free Magnets placed in every public housing apartment

The Green River District Health Department offered Freedom from Smoking Tobacco Cessation Facilitators training in Owensboro on September 26, 2017. Karen Ellis, Resident Services Coordinator, attended the training and was certified to conduct on site eight-week Freedom from Smoking Cessation classes. We distributed Smoke Free Surveys to all households and returned surveys were

entered into a drawing for a \$25 rent credit paid through the American Lung Association. Surveys help identified who was interested in the smoking cessation classes. Currently we have hosted two eightweek classes to residents with a seventy-five percent success rate becoming smoke free. Residents that completed the smoke free class received a one-time \$50 rent credit paid through the American Lung Association. One participate wrote "she participated in the 8 weeks smoke free program and at first she struggled for the first couple of weeks but pleased to say that it has helped her to completely quit and without the support of other members of the class and the instructor it probably would have been impossible."

The cessation class is also open to staff to participate. This program results in no expense to the Housing Authority of Owensboro with the exception of staff time but is a tremendous benefit to our residents and community.


The Housing Authority of Danville is excited to announce the hiring of Gwendalyn Campbell as our Resident Services Coordinator. Gwen was an intern for us through Eastern Kentucky's Social Work program in the Fall of 2017. She helped us create a Family Self-Sufficiency program, a Community Resource Guide, and an updated Resident's Handbook. Upon graduation in early 2018, we brought Gwen on as our full-time Resident Services Coordinator!

Dividends are already paying off as she has met with numerous residents through home visits and office visits, as well as meeting new move-ins. The Boyle County Public Library is partnering with us to donate thirty desktop computers for us to begin after-school and adult education programs at various sites. We had twenty-eight residents go through an Emergency Preparedness Training at one of our developments, with many more being connected with outside agencies as referrals. We have smoking cessation classes as well as credit repair and adult education classes coming up over the next few weeks.

Gwen is also working with the city and community partners to plan our first "Strong Families Initiative" event at one of our sites.

The Housing Authority of Danville looks forward to growing the FSS program and seeing residents meet goals and creating a path towards self-sufficiency!
