That gives housing authorities the ability to leverage your housing property for bank loans, LIHTC deals, etc. Of course, HUD stated that you still have the option of doing nothing and staying public housing. The Louisville HUD office has stated that they are willing to help you to look at the various options available to you. I would highly suggest if you are looking at RAD to hire a qualified consultant to assist you.

If you are looking at the possibility of RAD, Jason Casterline will be speaking at the Mid-Year Conference in February on the financial aspects of RAD.

Larnelle Harris has garnered numerous accolades for his music including five Grammy Awards, eleven Dove Awards (three of which were for Male Vocalist of the Year), and a Stellar Award for Best Solo Performance, among many other musical honors. Larnelle was recently recognized by his home state of Kentucky with the Governor's Award for Lifetime Achievement in the Arts, making him the first Christian artist to receive the award. He has achieved nineteen #1 radio singles and countless top 10 hits. Songs such as "How Excellent Is Thy Name," "I Miss My Time With You," "I've Just Seen Jesus," plus many others, including his signature song, "Amen," are now considered modern gospel music classics.
